Patrick Garrison: Having consistency of when names/forms are due. Keeping consistency for each event when they are due to avoid confusion. Bill Boardman: Adhering to some form of deadline for parents, students alike. Having hard deadlines where parents and students must adhere to which allows time to get Alternates and avoids other issues with alternate forms of payment. Students that didn't participate and knowing in advance to call alternates so that money that would be lost is still available to help pay for events.
