ix. Judges

1. We pay for judges like normal

- 2. We trade judging services with District IV
- 3. We judge for the other level (ie. HS for MS and MS for HS)

Discussion Notes:

Ashley Landon: Option of each teacher doing a dropbox/registration then sending it off to full organization after.

Lynne German: Dropbox being free is a great thing to consider. Students can make payments via Venmo, Zell, Cashapp, etc., where all money would be paid through.

Ashley Landon: Checks would need to come directly from the schools, which means that those avenues wouldn't be able to be used due to the rule in the manual. Money would have to come from the school/through the school's office.

Karla Robinson: If students submit audio/video to a dropbox then potentially students have the option of taking 30 takes. Which is something to consider. If a strictly audio recording is chosen then teachers would need to screen the recordings first to make sure that students are not auditioning for one another.

Lynne German: Second term students, cause a different dynamic with the audio screening that we might not know their voices yet or even spreading the word to those students. I like the idea of keeping it in house and having MS judge for HS and vice versa.

Bill Boardman: December date would be good, to give more time for students to be prepared which helps with the current virtual status.

Corbin: Using Opus where they would be a fee paid directly to the site, fee is dependent on the type of audition that we choose (\$2.50-\$15 depending on what we choose to include in the audition. Also needing to charge the 20 cents for VMEA).

Bill: Is it possible to look at how many students we want to use per ensemble with the judges fee and VMEA fees included into the audition fee. Where we don't actually have to touch the money.

Corbin: Vote to cut sight-reading out of the audition for this school year only in the Zoom Chat. Yes was voted. Same judges listening to the same voice parts is still required, however there is a grading window. So same day rules do not apply as long as all grades are completed within the window.

Sarah Haigh: Having District IV judge for us would be the better option and us judging for them if asked.

Corbin: Dec. 11-Dec.31 to score submissions.

Sarah Haigh: Are we willing to judge for District IV or judge our own district.

Vote: Are we willing to give your time for free to judge either for District IV or in house? Yes was voted.

Vote: Willing to trade services and judge for District IV? Yes was voted.

Corbin: Are we willing to do the Digital Dropbox or go through OPUS?

Ashley Landon: Would Music Administrators be willing to pay for the audition fee for the students in lieu of not paying for Assessments?

Holly Sunderland: Budgets have been cut.

Karla Robinson: Some choirs do require everyone to audition. Might this be the year that choirs do not require that to happen.

Vote: Using Opus for auditions?

Opus has it. Grading our own students or District IV's. More info to come later.

Carl Copon: How is the Honors Choir doing their virtual event?

Corbin: Paying an audio tech company to do it.

Carl: Is that an avenue that we want to pursue if we do a virtual choir event? We should have a plan, before completely pulling the entire event.

Bill Boardman: Would need to be in contact with the conductors to see if they are willing to do this? Why audition for Districts for a resume? They should get something out of it.

Lynne: Conductors should be able to plan for an event and knowing what they are getting into before the whole event occurs. Virtual is guaranteed right now, physical events are not yet.

Ashley: Date changes for the event are flexible.

Corbin:
